No Co-pays (Sin Copago)

You cannot pay 10 Dollars
at the doctor.

2

No Deductible

Coverage must start from
the first Euro.

3

No Waiting Periods (Sin Carencia)

You must be covered for
everything (including
hospitalization) from Day 1.

4

Repatriation

It must cover the cost of flying
your remains back to the US.

Understanding Your Healthcare Options

Public (Seguridad Social)

- ✓ Free (if you work)
- ✓ Covers pre-existing conditions
- ✓ Excellent for cancer/trauma
- ✗ Slow for non-emergencies
- ✗ Shared rooms

Private (Seguro Privado)

- ✓ Fast
- ✓ English-speaking doctors
- ✓ Private rooms
- ✓ Mandatory for visas
- ✗ Does not cover pre-existing conditions (usually)
- ✗ You pay for prescriptions (though they are cheap)
